*MAP Projects 3.2.1, 3.2.6, 3.2.7, and 3.2.9 needs support from department chairs. For the library to increase its circulation, it needs to revitalize its holdings with careful input from department faculty. Chairs who discuss resource needs with their faculty and convey that information via their department's library liaison assist in improving the quality of resources and the LLC's impact on teaching and learning.

** MAP Projects 3.2.4 and 3.2.5 need assistance from the Music and Education Departments. Not only do librarians need assistance with what books to remove from the collection, they need input on ways to improve the collection and its utilization.

Note: In the MAP, the LLC has requested \$500K to revitalize an outdated print collection. Currently, the ratio of obsolescent books being retired from the library to new books being purchased is 20 to 1. The end goal is not a one-to-one replacement; the collection is going to be smaller but more relevant. The library has shifted its funds and operations to purchase more books this year, but it is unlikely that the budget adjustments will be enough (hence the \$500K Foundation request).

Help Needed on MAP 3.3

*MAP Project 3.3.1 requires support from college deans and college faculty. Despite an award-winning course development process, the TLC has struggled to get traction in the area of instructional design. In the end, it is up to schools and departments to decide if they want to create programs that save students \$4,000-\$6,000 in textbook costs and meet ADA and copyright compliance standards. TLC and LLC staff can provide all kinds of support (see, for example: http://csc.edu/library/facultyinfo/bookrequest), but these units have little leverage when it comes to program planning and the curricula.

**MAP Project 3.3.3 needs support from Student Services, IT, and Dining Services. The LLC wants to improve upon how the units in the building work together to support the campus and the community. We are looking for ways to better utilize the talents of the people in the building and to "advertise" the LLC to faculty and students as THE PLACE on campus where a person can get help with almost anything.
